## Helping you understand legacy giving

#### What are the different types of legacy?

- A residuary legacy is all or part of your remaining estate after gifts to family and friends have been distributed and other expenses have been paid.
- A pecuniary legacy is a specific amount of money.
- A specific legacy is a non-cash gift, for example property, shares or a personal item of value.
- A reversionary legacy leaves your assets to a named beneficiary (perhaps your spouse or other dependents) for their lifetime for example, with the whole or a portion reverting to Freedom United on their death.
- A conditional legacy provides for the eventuality that if none of your dependents survives you, your estate will be left to other named beneficiaries, including, perhaps, Freedom United.

If you would like to remember Freedom United in your Will, here is some suggested wording which your lawyer might like to use. Please note that this is not intended as legal advice. We recommend seeking legal advice when writing or updating your Will to make sure that your wishes are carried out.

#### • Sample Residuary Clause

#### • Sample Pecuniary Clause

#### • Sample Specific Gift Clause
