- People belonging to ethnic, cultural, and religious groups in northwestern China, including Uyghurs, Kazakhs, Kyrgyz, and Hui, are currently the target of the largest organized detention of an ethnoreligious minority the world has seen since World War II.
- Since 2017, over one million have been detained.
- Survivor accounts, leaked official documents, and satellite imagery confirm that the Chinese government is subjecting hundreds of thousands of Uyghurs, Kazakhs, Kyrgyz, Hui, and other Turkic and Muslim people to systematic forced labor in detention camps, prisons, and factories.
- Countless Western companies are also profiting from this system of forced labor in their supply chains. Over 20 percent of the global apparel's cotton supply is grown in Uyghur Region,14 with 84 percent of China's supply grown in the province. Recent reports implicate at least 83 companies, in numerous different industries, in profiting from the forced labor.
- Although the Chinese government continues to deny any
 wrongdoing, we can draw attention to the issue and put pressure on
 them to end the use of forced labor. Western governments and
 corporations must end their involvement in implicated factories. By
 making it neither economically nor politically advantageous for the
 Chinese government to continue its current treatment of these
 people, we can make a difference.

CALL TO END SLAVERY IN LIBYA

- News of slave markets in Libya are shocking and cases of modern slavery, slave trade and slave auctions in Libya continue to evolve considerably. And they are all linked back to migrant detention centers and the money and power fueling their existence.
- In a bid to prevent refugees and migrants from reaching the shores
 of Europe, the Libyan Coastguard has increased its interception of
 boats in the Mediterranean Sea, returning those on board to Libya
 and locking them up in migrant detention centers.
- Conditions in these detention centers are horrific. Reports of torture, forced labor, and extreme physical abuse are rampant.
- We know racism within Libya is contributing to the problem as well; black and dark-skinned refugees and migrants from Sub-Saharan African are the majority of those trafficked and subjected to forced labor. The United Nations even reported that "a commonly used word to refer to black people in Libya is 'abidat', which translates to "slaves."
- The E.U. is complicit in the atrocities committed against people forcibly returned to Libya by continuing to fund the Libyan Coastguard.
- Call on EU governments to:
- Cease funding for the Libyan Coastguard
- Push to close all migrant detention centers in Libya, release and evacuate of all men, women and children currently detained there
- Set up of a disembarkation and relocation mechanism for people rescued in the Mediterranean Sea not tied to the Libyan Coastguard

END ORPHANAGE CHILD TRAFFICKING

- Criminals are profiting from the trafficking and abuse of children in orphanages around the world. Traffickers, attracted by the funding orphanages receive from donations and organizations offering 'voluntourism' placements, effectively turn children into commodities by ensuring there is a constant supply of children available to attract funding.
- Poor families are vulnerable to being duped into giving up their children to orphanages with false promises of better care and an education. Instead, these children are often exploited, abused, malnourished, forced to work and sometimes re-trafficked to other orphanages to repeat the cycle and bring in more funds. Child trafficking into and across orphanages is a global problem.
- 'Voluntourism' the practice of combining voluntary work with tourism – has become a popular trend,1 creating a boom in vacation packages involving volunteer work. It's clear that organizations offering orphanage placements can play a role in ending the cycle of abuse fueled by demand for volunteer placements, which traffickers are exploiting to profit from the mistreatment of vulnerable children.
- Ask volunteer tour operators to help stop orphanage trafficking by removing the financial incentive and making a strong statement against orphanage trafficking.
- Call on them to: stop offering orphanage placements to volunteers; publish a statement outlining their commitment to end orphanage child trafficking; join the worldwide movement to ensure children are raised in safe families empowered to care for their own children with the support of partners experienced in child protection.

END CHILD EXPLOITATION IN COCOA

- Child slavery and child labor have plagued the cocoa industry in Côte d'Ivoire and Ghana —which produce 60% of the world's cocoa—for decades. Despite promises from the world's largest chocolate companies to eradicate the problem, evidence reveals that they have fallen far short of achieving their goal.
- According to the 2020 United States Trafficking in Persons Report, young boys laboring on cocoa farms in Côte d'Ivoire and Ghana find themselves subjected to human trafficking and forced labor with victims forced to perform back-breaking, hazardous work that threatens their well-being. 5Some are trafficked from neighboring West African countries, such as Burkina Faso and Mali, and controlled by a "big boss" who exploits them.
- The world's top chocolate companies must take concrete steps to address the gaps in protection and the underlying drivers of child slavery and child labor in the cocoa sector.
- This means paying impoverished cocoa farmers living incomes, ending dangerous pesticide use—noting the high prevalence of child laborers and huge environmental toll—scaling up child labor monitoring and remediation systems, enactment of human rights due diligence measures, increasing traceability, and ending deforestation

STOP DETAINING SURVIVORS

- Alarmingly, survivors of modern slavery and trafficking are being detained in prison-like settings around the world. Their offense? Breaching immigration rules, often as a result of their exploitation.
- Aln countries such as the U.K., U.S. and Australia,1 there's not even a time limit on how long a survivor a can be held in immigration detention causing "immeasurable and unnecessary harm."
- Under the Palermo Protocol on Trafficking, the non-punishment provision3 urges states to ensure survivors are not held in detention nor prosecuted for crimes they were forced to commit as a result of their exploitation.
- Crossing a border, albeit without the right documents, doesn't inherently make someone a risk to society. In fact, immigration rules are often what makes them vulnerable to exploitation it allows traffickers to use the threat of detention to keep victims from seeking help.
- There is no justification for putting trafficking survivors behind bars when they have already been subject to a loss of liberty and severe exploitation. Yet, this is what is routinely happening to survivors.
- We're urging governments to stop detaining survivors for not having secure immigration status, and meet international standards designed to protect survivors from further trauma and revictimization.


