Helping you understand legacy giving

What are the different types of legacy?

- A residuary legacy is a percentage of your remaining estate, after gifts to family and friends have been distributed and other expenses have been paid.
- A pecuniary legacy is a specific amount of money.
- A specific legacy is a non-cash gift, for example property, shares or a personal item of value.
- A reversionary legacy leaves your assets to a named beneficiary (for example, your spouse or other dependent) for their lifetime, with the whole or a portion reverting to Freedom United on their death.
- A conditional legacy provides for the eventuality that if none of your dependents survives you, your estate will be left to other named beneficiaries including, perhaps, Freedom United.

If you would like to remember Freedom United in your will here is some suggested wording which your solicitor might like to use. Please note that this is not intended as legal advice. We recommend seeking legal advice when writing or updating your will to make sure that your wishes are carried out.

- **Sample Residuary Clause**

I give _____% of my real and personal property not hereby or by any codicil hereto specifically disposed of after payment of my debts, pecuniary and specific legacies, funeral and administration expenses and any taxes in respect of my estate to Freedom United, 5400 Glenwood Avenue, Suite G01, Raleigh, North Carolina 27612, USA, 501(c)(3) EIN 47-1249214 for the general purposes of the nonprofit. I direct that the receipt of the duly authorised officer of Freedom United shall be a sufficient discharge for my Executor/Trustees.

- **Sample Pecuniary Clause**

I give the sum of £_____ free of tax Freedom United, 5400 Glenwood Avenue, Suite G01, Raleigh, North Carolina 27612, USA, 501(c)(3) EIN 47-1249214 for the general purposes of the nonprofit. I direct that the receipt of the duly authorised officer of Freedom United shall be a sufficient discharge for my Executor/Trustees.

- **Sample Specific Gift Clause**
